Are you a dialysis patient with plans to visit Amsterdam? Perhaps you intend to be in the capital of the Netherlands for business. If you have written permission from your Nephrologist, OLVG, locatie West welcomes you!

Guest Dialysis

Receiving your dialysis treatment at OLVG, locatie West (voorheen Sint Lucas Andreas Ziekenhuis) has many advantages including:

- An innovative hospital setting with all necessary facilities;
- Easy access by public transport;
- Schiphol Airport, Amsterdam city center and Conference center RAI are all conveniently and closely located;
- Recently renovated and one of the largest dialysis facilities of The Netherlands;
- Hospital parking is available.

OLVG will gladly accommodate your guest needs during your stay in Amsterdam!

What is necessary for guest dialysis?

- Have written permission from your Nephrologist;
- Before you come it's necessary to have a test result of Covid, MRSA and BRMO. It's taken not longer than 72 hours.
- Contact us four to six weeks prior to your arrival in Amsterdam either via [emailing](#) or by calling +31 2 5108390 to reserve your space in our dialysis facility;
- Once we confirm availability we kindly ask to have your home dialysis facility fax your medical/nursing records to +31 2 683 7720. Our facility administrator and Nephrologist will evaluate these records and contact you promptly to confirm reservations for your treatment.

What is the cost of a treatment for a dialysis guest?

For dialysis patients visiting Amsterdam from within Europe, a payment guarantee from your health Insurance provider should suffice. Patients visiting from outside Europe will generally be required to pay the hospital directly. The total cost per dialysis treatment is roughly €380.00 which you can re-claim by your health insurance provider.

Can family members attend my dialysis treatment?

You are permitted to take along one family member during your treatment. We do request, however, for safety purposes that your guest wait in our waiting room during the initiation and termination of your treatment.
